Registration Terms and Conditions

All participants signing up for the Amazing Thailand Social Golf 2022 shall be deemed to have read, understood and accepted the following Terms and Conditions:

1. ORGANIZER AND MARKETING PARTNERS

- a. The Amazing Thailand Social Golf 2022 ("Phuket Golf") is organized by the Tourism Authority of Thailand Singapore Office ("TAT Singapore") and managed by TAT Singapore's Appointed Event Management Partner, Concepts Golf Management Pte Ltd ("Event Manager").
- b. The Phuket Golf is promoted by TAT Singapore's appointed Marketing Partners. TAT Singapore reserves the right to appoint marketing partners for this event.

2. EVENT REGISTRATION AND PAYMENT

- a. Participants can register for the Phuket Golf through TAT Singapore's Marketing Partners between **1 March 2022** and **6 April 2022**, subject to availability.
- b. To register, EACH Participant must complete the Phuket Golf Registration Form, acknowledge the Registration Terms & Conditions and with Full Payment of the event fee/s. These documents must be received (by email or fax) by TAT Singapore or the Event Manager before **6 April 2022**. The full payment must be made within FIVE (5) business days from the date of receipt of the emailed/faxed Registration Form(s) and the signed Terms & Conditions, failing which the booking may be released. Subsequent registration(s) shall be subject to availability.
- c. For Participants registering through TAT Singapore's Marketing Partners, the Marketing Partners must submit the same documents and fees as described in Clause 3(b).

3. MINIMUM GROUP SIZE AND CAPACITY

- a. The Phuket Golf will require a minimum of 80 golfers to proceed. TAT Singapore will endeavour to notify all Participants at least one (1) week before the event if the Phuket Golf cannot proceed as planned and has to be cancelled due to unforeseeable circumstances, including but not limited to an insufficient number of participants. A refund of event fees paid will be made, and TAT Singapore shall not be liable for any further responsibility. TAT Singapore may, if it so decides, recommend alternative arrangements.
- b. The maximum capacity is 144 golfers on a first-come-first-serve basis. TAT Singapore reserves the right to refuse entry should capacity be exceeded.

4. FLIGHT PAIRING

- a. You are able to submit your own flight pairing/s at the time of booking. TAT reserves the right to pair up golfers to make a flight for any incomplete flight(s) submitted.

5. GOLF GAMES & CADDY

- a. For the safety of golfers, the course(s) shall declare closed if it is considered unplayable due to rain, lightning, or any other reasons. The Cancellation and Golf Course Closure policies are governed by the rules and regulations laid down by the respective Golf Clubs.
- b. Twin share cart and caddy at Aquella Golf & Country Club
- c. Single cart and caddy at Loch Palm and Red Mountain Golf Club

6. COVID-19

The spread of Coronavirus has created uncertainty for international travellers as well as travel organizers and our local supplier partners. Despite the uncertainty, we still have a commitment with the relevant suppliers, if in the unfortunate event that you are restricted from travelling as planned or cannot travel due to official restrictions, we will endeavour to find a workable solution to re-arrange your trip or assist in providing the necessary documentation to support your travel insurance claims.

6.1 VOLUNTARY CANCELLATION

Should the Participant(s) choose not to travel despite there being no travel ban in force in either their local government or the destination, the entire package price shall be entirely forfeited. All cancellations should be made in writing to TAT Singapore or the Event Manager.

7. AMENDMENTS

All Participants' names are final at time of reservation and cannot be varied. You may submit a written request for a name change or rectify errors to a Participant's name at least two (2) weeks before the event arrival date. We will endeavour to accommodate or facilitate your request to the best within our purview. We will endeavour to confirm the status of any request for an amendment within ten (10) days of receiving your written request.

8. TRAVEL DOCUMENTS & ARRANGEMENTS

You are responsible for obtaining and producing all proper documentation such as valid passport, visa, vaccination records, required health screening test(s), travel records, travel insurance, and other necessary documentation and arrangements. You are also responsible for ensuring the accuracy and completeness of all documentation and information required by the relevant authorities in your destination.

Any cancellation of reservations due to the Participant(s) failure to obtain any proper and necessary documentation as mentioned shall result in forfeiture of the full package price.

TAT Singapore and its partners shall not, in any event, be held liable under any circumstances for any loss, damage or expenses, should any Participant be deported or refused entry by the relevant authorities of the destination(s) for any reason whatsoever. These reasons include but are not limited to irregular travel documents, quarantine restrictions, customs regulations and restrictions, possession of unlawful items or other criminal activities.

9. THAILAND PASS APPLICATION

All participants visiting Thailand must obtain a Thailand Pass. Thailand Pass application is at www.tp.consular.go.th (the application process requires up to 7 working days for approval). The documents required for the Thailand Pass application are

- i) Passport & Visa (if required)
- ii) Notarised Vaccination Certificate
- iii) Medical Insurance Policy with minimum coverage of USD 20,000 or equivalent in SGD
- iv) Accommodation Booking Receipt in a SHA Extra Plus hotel for Day 1 that includes arrival transfer to Hotel (TAT/CGM will provide this document),
- v) RT-PCR Booking Receipt for Day 1, Book & Pay at <https://www.thailandpsas.com/>

10. SPECIAL REQUESTS

Participant(s) is responsible for informing TAT Singapore or its partners of any special request(s) for dietary requirements, seating arrangements, flight pairing, etc., at the time of their booking, if applicable. All such requests are subject to availability and confirmation. TAT Singapore and Event Manager shall not be held liable if these request(s) are not met for any reason.

11. REFUND POLICY ON UNUSED PORTION OF THE EVENT PACKAGE

No refund will be made to accommodation, meals, or any other services included in the event package but not utilized by the Participant, either in part or full, or where the Participant amends, cancels or otherwise varies his/her arrangements after the start of the event.

12. AMENDMENT TO ITINERARY (BY ORGANIZER)

TAT Singapore and its partners shall make a reasonable effort to avoid itinerary changes. However, they reserve the right to make changes at any time due to unforeseen circumstances or in the event of a force majeure.

13. TRAVEL INSURANCE

It is up to the Participant to determine whether they need travel insurance or to assess the adequacy of their existing insurance(s). However, it is mandatory for all Participants visiting Thailand to possess a COVID-19 medical insurance policy with a minimum coverage of USD20,000 or its equivalent in SGD. We strongly encourage all Participant(s) to take up a comprehensive travel insurance policy (that includes COVID-19 coverage) to protect against the failure or disruption in the provision of the travel products purchased arising out of any insolvency on either party. Please inquire with your Travel Agent about purchasing the appropriate travel insurance for this trip.

14. NOTICE OF PHOTOGRAPHY AND FILMING

- a. By registering for the Phuket Golf, participants consent to interview(s), photography, audio/ video recording and its release, publication, exhibition or reproduction to be used for news, webcasts, promotional purposes, telecasts, advertising, inclusion on websites, social media and/or any other purpose by TAT Singapore and its affiliates and representatives.
- b. All recordings, articles, quotes, photographs, films, audio or video and/or any reproductions of same in any form, are the property of TAT Singapore. TAT Singapore, its affiliates, employees, representatives and agents are released from any and all claims, demands, costs and liability that may arise from the use of these interviews, recordings, photographs, videotapes or films, and/or any reproductions of same in any form, as described above, arising out of being interviewed, recorded, photographed, videotaped or filmed.
- c. It is the responsibility of participants to remove themselves from group and candid shots/recordings that the photographers/videographers intend to capture, if they do not wish to have their photos/audio-visual recordings taken during the event.

15. LIABILITY

Without limitations to any other provisions of these Terms and Conditions, and to the fullest extent permitted by the law, TAT Singapore and its partners shall not be responsible or assume any liability to any Participant(s) for: any injury, damage, loss or delay affecting any person or property not arising from our negligence or breach; any loss, damage, cost, expense or delay suffered or incurred due to circumstances beyond our reasonable control, including but not limited to:

- actions or omissions of third parties (including any applicable third-party service providers); mechanical breakdowns;
- Force Majeure Event(s);
 - o Participant(s) failure to comply with any of their obligations hereunder;
 - o Participant(s) failure to possess, obtain or maintain any travel documentation required for the trip (e.g. health certificates, visas, valid passports, etc.);
 - o Participant(s) failure to follow reasonable instructions, including but not limited to complying with specified check-in/ out, gathering at meeting places and/or time(s) etc.

To the fullest extent permitted by the law, our maximum liability to any traveller for any loss, damage, cost and/or expense shall not exceed the amount of the package paid to and received by us in respect of such Traveller.

TAT Singapore and its partners shall not be liable for any punitive, special, indirect or consequential loss or damage, including loss of production, profit, revenue and/or damage to goodwill or reputation.

You agree to indemnify us, our affiliates and our respective officers, directors and employees against all claims, liabilities, damages, costs and expenses, including legal fees (on a full indemnity basis) arising out of any breach of these Terms and Conditions by you.

16. CHANGES TO TERMS & CONDITIONS

TAT Singapore reserves the right to change, amend, insert or delete any of these Terms and Conditions or policies contained therein where necessary.

17. FINAL DECISION

TAT Singapore reserves the right to make the final decision on matters relating to the Phuket Golf.
